Welcoming words from **LASA President**

LASA / Asia Regional Congress, 2022

It is my great honour to welcome LASA members to the association's first Asia Regional Congress. Participants, I'm told, are not only from this region but also from Latin America and the United States, colleagues who focus on Asia's relations with Latin America and the Caribbean. I start with my deep thanks to the East Asian Network of Latin American Studies for its help in organizing this event, and to our past president, Gioconda Herrera, and her team of organizers.

You will recall the central topic of our LASA2022 International Congress: "Socioenvironmental Polarization and Rivalry among Great Powers." Rivalry among great powers is of special significance to colleagues gathering at this Asia Regional Congress because of the location of the rising China. I call your attention to the Summer 2021 issue of LASA Forum, in which several LASA colleagues contributed excellent articles on China-LAC relations. In my introduction to this section, I expressed my concern about the troubling reaction to China's rise by the United States: "The growing rivalry between the United States and China places Latin America and the Caribbean (LAC) in a complicated situation. On one hand, since its imperial rise in the nineteenth century, the United States has been a forceful power which tries to extract the greatest advantage from the region and does not hesitate to intervene in its political processes. On the other, China has emerged in the twenty-first century with a significant presence in all imaginable ambits. How should the countries of LAC confront this rivalry among great powers to minimize conflict and maximize the benefits to their people?"

I have personally been awfully apprehensive about the belligerent posture adopted by U.S. President Joseph Biden since the start of his administration. Not only has he continued the trade war with China started by his predecessor, but he has aggravated the tone of the rivalry, making it sound more like a confrontation. For Biden, the rivalry

goes well beyond international trade. He has pitched it as a contest between democracy and autocracy, which to me seems far-fetched. And I am not the only one. Some foreign policy experts are concerned that "it is the U.S., not China, which is worsening tensions by reading more into its rival's behaviour than the situation merits" (John Rapley in The Globe and Mail, January 28, 2022).

Latin America would greatly benefit from the emergence of a multipolar world in which trading partners multiply and coexist peacefully. The worst outcome for the region is that the U.S. government were to push its countries into choosing whom they want to be friendly with for trade, investment, and other exchanges. This "us-or-them" posture would lead to a zero-sum logic. Politicians and scholars of Asia-LAC can and should play a mediating role to promote cooperation or competition among powers in a multipolar world, while reducing or eliminating conflict. The relations among China, Latin America, and the United States could thus take on a positive-sum character instead.

Our collective concern should be focused on the existential catastrophe of climate change and overcoming socioeconomic inequalities that have deepened since the 1980s. International relations ought to be kept friendly and cooperative. Hopefully your discussions in this first LASA Regional Congress in Asia will devise some specific ways to attain this. I leave you with my best wishes for a stimulating and productive intellectual exchange.

Best Practices for Virtual Sessions

- Test your video and audio before your session.
 - If possible, use a wired ethernet connection rather than a WiFi connection.
 - Close any unnecessary applications or programs that your computer is running and you are not using.
 - Use a headset with an inline microphone during your participation instead of the built-in microphone/speakers on your computer. A headset focuses the microphone on your voice, cuts down on background noise, and minimizes echo.
 - Choose a quiet space. Be mindful of sounds in the background, and mute your cell phone to avoid interruptions.
 - If possible, put your laptop or desktop computer on a stack of books, so that the camera is at your eye level.
 - Avoid backlighting, or having a window or lamp behind you. Whether natural or artificial, the light should always come from the front. Lighting from the back will make it difficult for participants to see your face.

Today Brazilian music is experiencing an unprecedented moment with the arrival of musicians from different African countries in the metropolis of São Paulo. In an attempt to preserve fragments of a disappearing culture, Mateo walks across communities in the arid and desolate Paraguayan Chaco region and registers on cassettes the experiences of other Ayoreo who, like him, were born in the vast forest, free and nomadic, without any contact with white civilization, until religious missionaries forced them to abandon their ancestral territory, their means of subsistence, their beliefs and their home. Apenas el Sol is Paraguay's official submission for International Feature Film, Best Documentary Feature, at the 94th Academy Awards.

She has worked as a filmmaker and actress in different cities and countries around the world: Costa Rica, Moscow, France, Kazakhstan, Georgia, Damascus, Iraq, Lebanon, Chile, Argentina, Nicaragua, Haiti, and Mexico. Dos Fridas is inspired by a true story: Judith Ferreto lives her last days of life in her house in Costa Rica. The closeness with death leads her to relive her memories of when she was the personal nurse of the Mexican painter Frida Kahlo. The film interweaves popular art, exvotos, death imagery, surrealism, and the twentieth-century artists and thinkers of post-revolutionary Mexico.

The documentary proposes to reflect on the value of work and the identity of a Korean family that has lived longer in Argentina than in their homeland.
